

PERSONAL DATA PROTECTION AND PROCESSING POLICY

I. OBJECTIVE OF THIS POLICY

The purpose of this policy is to outline how Condor Travel S.A.C. (hereinafter "Condor Travel") protects and processes the personal data of clients, passengers, suppliers, tourism operators, travel agencies, and collaborators, from its collection through various channels, whether physical or digital, for the purposes duly communicated.

II. GENERAL INFORMATION

Condor Travel, a company belonging to the Expertia Travel Group, provides services related to individual and group travel, whether by air, sea, or land, organizes tours or excursions, secures accommodations, and performs other activities directly related to tourism. To this end, information is collected, used, managed, transferred, stored, and processed that can be associated with information belonging to natural persons in the course of its activities. Examples include: name, identity document, phone number, email address, country of residence, among others, collected through various physical and digital formats.

Condor Travel, in compliance with Peruvian Law No. 29733 – Law on Personal Data Protection – and its Regulation No. 016-2024-JUS, is committed to guaranteeing and adopting measures for information security through international best practices, ensuring the confidentiality, integrity, and availability of personal data provided.

III. DEFINITIONS

- Data Controller: The individual or legal entity that, alone or jointly with others, determines the purposes and means of processing personal data; that is, Condor Travel will be responsible for the personal data obtained through its various collection channels and provided by the users of Condor Travel, as well as by the companies that are part of it.
- Personal Data: Any information about an identified or identifiable natural person (the user), such as their name, national ID (DNI), passport, location data, or one or more elements specific to the physical, physiological, genetic, psychological,





economic, cultural, or social identity of the person.

- Processing: Any operation or set of operations performed on personal data or sets of personal data (automated or not), such as collection, recording, organization, modification, consultation, use, dissemination, or any other form of enabling access, matching, or interconnection, restriction, deletion, or destruction of personal data.
- Right of Access: The user's right to know what data Condor Travel is processing and to obtain a copy of it.
- Right of Rectification: The user's right to update, rectify, and/or correct their personal data.
- Right of Opposition: The user's right to oppose at any time the processing of their personal data by Condor Travel.
- Right of Cancellation ("Right to Be Forgotten"): The user's right to request the deletion of their data in any document, file, or location where it is accessible

IV. CONSENT AND LEGITIMIZATION OF PROCESSING

Condor Travel processes user data:

- (i) When users expressly give their consent for the processing of their personal data for the purposes detailed in this document and/or;
- (ii) When processing is necessary for the execution of a contract for services and products in which the user is a party.

V. PERSONAL DATA SUBJECT TO PROCESSING AND SCOPE



This policy applies to the personal data corresponding to clients, passengers, suppliers, tourism operators, travel agencies, and collaborators, provided voluntarily and knowingly. The information collected and stored includes basic data entered through registration, contact forms, or similar mechanisms, such as name, national ID (DNI), passport, gender, age, phone number, email address, country of residence, among others, collected through the various channels managed by the company, necessary for providing Condor Travel's tourism services. Users can see which data are essential for the proper delivery of the service and which are optional before submitting their personal data.

The user is solely responsible for the accuracy and truthfulness of the data provided. Only individuals over 18 years of age and/or those with sufficient legal capacity may be users. Additionally, the user is solely responsible for data provided about third parties and for ensuring they have informed them about this Privacy Policy and obtained their express consent.

VI. GOVERNING PRINCIPLES

Condor Travel adheres to the following principles in processing personal data:

- a. Principle of Legality: The processing of personal data under Law 29733 is a
 regulated activity that must comply with the provisions of this law and its regulations.
 The collection of personal data by fraudulent, unfair, or unlawful means is prohibited.
- b. Principle of Consent: The processing of personal data is lawful when the data subject has given their free, prior, express, informed, and unequivocal consent. Implicit consent or consent that is presumed, assumed, or obtained indirectly is not permitted. Even consent provided with other declarations must be expressed clearly and explicitly.
- c. Principle of Purpose: In accordance with the principle of purpose, it is considered that a purpose is determined when it is clearly expressed, leaving no room for confusion, and when the objective for processing personal data is objectively specified. In cases of personal data banks containing sensitive data, their creation can only be justified if their purpose is not only legitimate but also specific and consistent with the activities or explicit purposes of the owner of the personal data bank. Professionals handling any personal data, in addition to being bound by the purpose of their services, are required to maintain professional confidentiality.
- d. **Principle of Quality:** The personal data to be processed must be truthful, accurate, updated as much as possible, necessary, relevant, and adequate concerning the





purpose for which they were collected. They must be kept in such a way as to guarantee their security and only for the time necessary to fulfill the purpose of the processing.





- e. **Principle of Proportionality:** All processing of personal data must be appropriate, relevant, and not excessive concerning the purpose for which the data was collected.
- f. Principle of Security: The owner of the personal data bank and the person in charge of its processing must adopt the necessary technical, organizational, and legal measures to ensure the security of personal data. The security measures must be appropriate and consistent with the processing to be performed and the category of personal data involved.
- g. **Principle of Resource Availability:** Every personal data owner must have the necessary administrative or judicial channels to claim and enforce their rights when these are violated through the processing of their personal data.
- h. Principle of Adequate Protection Level: For cross-border personal data flows, a sufficient level of protection must be guaranteed for the personal data to be processed, or at least equivalent to what is provided by the law or by international standards in the matter.
- i. Principle of Transparency: Condor Travel is committed to the privacy of its clients and, in compliance with Law No. 29733, adopts measures to ensure adequate protection of personal data, as well as ensures that all information about personal data processing is clear, accessible, and available to the owners.
- j. Principle of Proactive Accountability: Condor Travel adopts proactive practices in personal data management, such as implementing processing records, conducting periodic risk assessments, and internal training, ensuring protection and respect for the rights of the owners.

VII. PURPOSES OF PERSONAL DATA PROCESSING

Condor Travel uses the personal data provided by users for the following purposes:



<u>Passengers (stored in the bank named "Customer Database" with Registration RNPDP-PJP No. 14236):</u>


- To fulfill the objective of providing the contracted tourism services and products: programming and booking flights, travel packages, hotel reservations, itinerary planning, as well as car rentals and insurance services, among others.
- To contact the client (travel agencies, companies, and natural persons) during the provision of the contracted services and products to address questions, inquiries, and requests.
- To facilitate coordination with suppliers, travel agencies, cruises, and hotels.
- To send information related to the nature of the service and/or mandatory knowledge and compliance provisions during the acquired service or travel package, such as terms and conditions.
- To issue digital advertisements for promotions or travel packages (applicable only if the user has given their consent).
- To substantiate the settlement of Non-Domiciled VAT before Tax Authorities through passport information and Andean Migration Cards (TAM), among others.
- To analyze and identify the expectations and preferences of travel agencies for acquiring tickets and services (applicable only if the user has given their consent).

Workers and Collaborators (This information will be stored in the database named "HUMAN RESOURCES - CONTRACTS" with registration RNPDP-PJP No. 14108):

- The company will request personal information from its workers to comply with current labor regulatory requirements and/or for the development of projects related to Human Resources and Talent Management, such as payroll registration, staff attendance, personnel selection, commission payments, among others.
- To comply with the policy and procedures of the Anti-Money Laundering and Counter-Terrorism Financing Prevention Policy.

<u>Tour Operators and Suppliers</u> (This information will be stored in the database named <u>"SUPPLIERS"</u> with registration RNPDP-PJP No. 14103):

To manage the payment of the requested services and products.





To contact you regarding the provision of the contracted services and products.

The personal data you provide will be stored in the databases described in Annex 2 of this document.

VIII. RIGHTS OF DATA SUBJECTS

The data subject shall have the following rights:

- a. The rights to information, access, rectification, cancellation, objection, and objective processing of personal data may only be exercised by the data subject, without prejudice to the regulations governing representation.
- b. The exercise of one or more of these rights does not exclude the possibility of exercising others, nor can it be understood as a prerequisite for exercising any of them.
- c. To know, update, and rectify their personal data with Condor Travel or the designated data processor. This right may be exercised, among others, regarding partial, inaccurate, incomplete, fragmented data that may lead to errors, or data whose processing is expressly prohibited or unauthorized.
- d. To be informed by Condor Travel or the designated data processor, upon request, about the use that has been made of their personal data.
- e. To revoke consent and/or request the deletion of data when the processing does not respect constitutional and legal principles, rights, and guarantees. Revocation and/or deletion shall proceed when the National Authority for the Protection of Personal Data has determined that Condor Travel or the designated data processor has engaged in actions contrary to Law 29733 and the Constitution.
- f. To access, free of charge and under the conditions defined in this document, their personal data that has been processed.

IX. SECURITY OF PERSONAL DATA

Condor Travel complies with the legally required personal data protection measures and





has adopted reasonably enforceable measures in accordance with current technical knowledge and best practices for the safeguarding and management of information. These measures aim to prevent the loss, misuse, alteration, unauthorized access, and theft of the personal data provided by users.

X. PROCEDURES

The data subject or their successors have the right to submit inquiries and/or claims to Condor Travel, upon verification of their identity, through a written request addressed to the following address. At any time, they may withdraw their consent for the processing of personal data and/or exercise their rights to access, information, rectification, objection, deletion, restriction, erasure, portability, and not being subject to individualized decisions, by submitting a written request addressed to Condor Travel with the reference "PERSONAL DATA" to the following addresses:

Condor Travel will respond to the inquiry and/or claim through the same medium in which it was submitted.

XI. DUTIES OF CONDOR TRAVEL IN DATA PROCESSING

- Guarantee the data subject, at all times, the full and effective exercise of the right to habeas data.
- Request and retain, under the conditions established by law, a copy of the respective authorization granted by the data subject.
- Properly inform the data subject about the purpose of data collection and the rights granted by the authorization provided.
- Take measures aimed at safeguarding the information under secure conditions to prevent its alteration, loss, unauthorized or fraudulent consultation, use, or access.
- Ensure that the information provided to the Data Processor is truthful, complete,





accurate, up-to-date, verifiable, and understandable.

- Update the information, promptly notifying the Data Processor of any changes to the data previously provided, and take all necessary measures to ensure that the information remains up-to-date.
- Rectify any incorrect information and notify the Data Processor accordingly.
- Provide the Data Processor, as applicable, only the data whose processing has been previously authorized in accordance with the provisions of the law.
- Require the Data Processor to always respect the security and privacy conditions of the data subject's information.
- Handle inquiries and claims submitted within the terms established by law.
- Adopt an internal manual of policies and procedures to ensure proper compliance with the current law, particularly regarding the handling of inquiries and claims.
- Inform the Data Processor when specific information is under dispute by the data subject, once a claim has been filed and the respective process is pending resolution.
- Inform the data subject, upon request, about the use of their data.
- Notify the National Authority for the Protection of Personal Data when security policy violations occur, and there are risks in managing the data subjects' information.
- Comply with the instructions and requirements issued by the National Authority for the Protection of Personal Data.
- Implement controls to ensure the security of personal data. Additionally, conduct data protection impact assessments when data processing activities may pose high risks to the rights of the data subjects, as required by Supreme Decree No. 016-2024-JUS.






XII. DUTIES OF THE DATA PROCESSOR

Data Processors must fulfill the following duties, without prejudice to other provisions established by law and any other regulations governing their activities:

- Guarantee the data subject, at all times, the full and effective exercise of the right to habeas data.
- Take measures to safeguard information under the necessary security conditions to prevent its alteration, loss, unauthorized or fraudulent consultation, use, or access.
- Promptly update, rectify, or delete data in accordance with the terms of the current law.
- Update information reported by the data controllers within five (5) business days from the date of receipt.
- Handle inquiries and claims submitted by data subjects in accordance with the terms established by law.
- Adopt an internal manual of policies and procedures to ensure proper compliance with the law, particularly for addressing inquiries and claims from data subjects.
- Refrain from circulating information that is under dispute by the data subject and has been ordered to be blocked by the National Authority for the Protection of Personal Data.
- Allow access to information only to authorized individuals who are entitled to have access to it.
- Notify the National Authority for the Protection of Personal Data in cases of security policy violations and when there are risks in the management of the data subjects' information.





- Comply with the instructions and requirements issued by the National Authority for the Protection of Personal Data.
- Safeguard the security of the databases containing personal data.
- Maintain confidentiality regarding the processing of personal data.

XIII. SECURITY MEASURES

Condor Travel takes all reasonable precautions and implements technical, administrative, and organizational measures to ensure the security of personal data belonging to data subjects, primarily aimed at preventing its alteration, loss, unauthorized processing, or access.

In the event of a security breach compromising personal data and affecting the fundamental rights of the data subjects, Condor Travel will notify the National Authority for the Protection of Personal Data within 48 hours of detection, in accordance with Article 34 of the Regulation approved by Supreme Decree No. 016-2024-JUS. Additionally, it will inform affected data subjects, where applicable, about the measures taken to mitigate the impact.

The application of these security measures is aimed at ensuring the preservation, confidentiality, integrity, and availability of data.

Condor Travel's security guidelines are supported by its information security policies, which are based on the best practices and existing security standards while complying with current regulations.

These policies are strictly enforced by both direct and indirect personnel performing duties within Condor Travel.

XIV. DATA RETENTION

The retention periods for users' personal data by Condor Travel will vary depending on the purpose of the processing. As such, data will be retained for as long as a contractual relationship for the provision of products and services exists between Condor Travel





companies and the users, and/or until the users request the deletion of their personal data from Condor Travel.

Additionally, users understand and accept that certain personal data must be retained by Condor Travel to comply with legal regulations and according to the timeframes established by law.

XV. OUR COOKIE POLICY

a. How can users configure cookies?

By accessing our platforms, you explicitly recognize and accept that Condor Travel may use a behavior tracking system through "cookies" and/or similar tracking technologies. These technologies help us understand the interests and behaviors of visitors or users of Condor Travel's platforms.

b. What do we use the information obtained from cookies for?

As part of the operation of our platforms, we use cookies for various purposes, including:

- Analyzing the pages you browse.
- Studying your searches.
- Promoting and enforcing site rules and security.
- Allowing users to avoid re-entering their password frequently during a browsing session.

Your personal data obtained through cookies and tracking technologies will be used solely for the purposes outlined above and will not be transferred to third parties.

c. How can you configure your cookie preferences?

Please note that the installation, persistence, and existence of cookies on your computer or device depends on your decision, and they can be deleted at any time. You can configure your cookie preferences directly from your browser.

d. How can I delete cookies?





At any time, users can delete stored cookies, configure their browser to request approval before storing cookies, or prevent cookies from being stored altogether.

This procedure varies by browser, and the process must be completed on each browser you use.

Please note that if you disable cookies, you may not be able to use all the functionalities offered by Condor Travel. For example, you may not receive personalized advertising aligned with your interests and searches while using your account.


e. What are the different types of cookies?

Cookies are specific types of information that a website sends to a user's computer hard drive or other device to keep records. Cookies can facilitate the use of a website by saving your settings and preferences while browsing the Internet. Cookies cannot load malicious code of any kind, nor can they carry viruses or malware, and they do not harm your device.

Our websites use different types of cookies:

- Essential cookies: These are used to recognize you when you log in, save your configuration preferences, and protect your account. They cannot be disabled as they are necessary for the functioning of our site.
- Analytical cookies: These allow us to observe visitor browsing behavior on the website to improve user experience. The data collected is aggregated and anonymized.

Although you can manage cookie usage from your browser, our platform will display a popup when you first access the website, requesting your consent for the use of cookies. At

that time, you will have the option to approve which types of cookies you allow and which ones you do not. Note that this option typically appears only when you access the website for the first time.

XVI. CHANGES TO THE POLICY

Condor Travel may make changes and updates to this policy based on new legislative, judicial requirements, and/or institutional needs, among others. Therefore, users are advised to review this policy regularly and/or each time they access the company's website.




